APPLICATION FOR WATER USE FEE REBATE

Applications for water use fee rebates must be filed with the District no later than 90 days from the date that annual water use fees are due.

Please read the following instructions and attached copy of District Rule Section 10 before completing and returning this application.

- Complete this form for EACH permit for which you are requesting a water use fee rebate.
- Application for water use fee rebates must be for amounts that equal or exceed \$10.00 (ten dollars).
- If eligible, permittee may receive reimbursement of paid water use fees up to an amount, **not to exceed ten (10) percent** of the total paid water use fees. Any applicable reimbursement may be made in the form of a direct rebate or as a credit toward water use fees accrued for the permit term following the term for which the rebate is sought.

An applicant for a water use fee rebate must present sufficient evidence that:

- The water production that serves as the basis for the rebate request was measured and recorded by a properly installed water meter that was calibrated in accordance with District rules, and that was competently operating at all times during the applicable production year; and
- The total amount of actual groundwater withdrawn during the applicable production year was less than the total amount of groundwater authorized to be withdrawn under the terms of the applicable permit.
