President and Presiding Officer Tramm called to order the Public Hearing on Amendments to Permits to Establish Total Qualifying Demand under the District Regulatory Plan and appointed Brian L. The Co-Presiding Officer observed that the following notice requirements had been met:

(2) The General Manager provided notice of the proposed permit amendments and hearing to each permit applicant and each person who requested a special notice under the District Rule; and posted it at the District Office and at the County Courthouse.

Brian Sledge, General Counsel, reminded the Board that after last month's hearing, there was one application for T & W Water Services which was postponed pending further research by District staff. Mr. Sledge allowed the opportunity for the public to contest the permit amendment. There being no applicant or interested parties present to contest, Mr. Sledge asked the Board consider the matter uncontested and move forward.

Item #1, **Montgomery County MUD** #105 - Applicant is requesting an amendment to an Operating Permit for an increase in production authorization in the amount of 5,000,000 gallons for 2015 and 35,000,000 gallons for 2016 and annually thereafter. Based on technical review of the

information supplied, it is the General Manager's recommendation to approve that which is being requested.

Item #2, **Rusted Rock Barn**, **LLC dba Big Sky Barn** - Applicant is requesting registration of a new well and production authorization in the amount of 120,000 gallons for 2015 and 1,600,000 gallons for 2016 and annually thereafter. Based on technical review of the information supplied, it is the General Manager's recommendation to approve that which is being requested.

Item #3, **Montgomery County MUD** #139 - Applicant is requesting an amendment to an Operating Permit for an increase in production authorization in the amount of 2,000,000 gallons for 2015 and annually thereafter. Based on technical review of the information supplied, it is the General Manager's recommendation to approve that which is being requested.

Item #4, Craig A. Gorewitz - Applicant is requesting registration of a new well and production authorization in the amount of 300,000 gallons for 2015 and 1,000,000 gallons for 2016 and annually thereafter. Based on technical review of the information supplied, it is the General Manager's recommendation to approve that which is being requested.

The Board of Directors of the Lone Star Groundwater Conservation District ("District") met in regular session, open to the public, in the Lone Star GCD - James B. "Jim" Wesley Board Room located at 655 Conroe Park North Drive, Conroe, Texas, within the boundaries of the District on October 13, 2015.

CALL TO ORDER:

President Tramm called to order the regular Board of Directors meeting at 10:25 a.m. announcing that it was open to the public.

PUBLIC COMMENT:

There were no public comments to report.

APPROVAL OF THE MINUTES:

President Tramm stated the Board would consider all meeting minutes listed as one item. Ms. Jones suggested that due to comments received from several board members this morning that the minutes of the September 8, 2015 Regular Board of Directors Meeting be removed, amended, and re-listed for approval at next month's meeting. With no further discussion, a motion was made by Director Stinson, seconded by Director Moffatt, and unanimously carried, to approve the meeting minutes listed below, with the exception of the September 8, 2015 Regular Board Meeting Minutes. *Copies of the minutes are attached hereto as Exhibit "B"*

COMMITTEE REPORTS:

A. Executive Committee - Richard J. Tramm, President

- 1) <u>Brief the Board on the Committee's activities since the last regular Board meeting</u> President Tramm stated that there was nothing new to report.
- 2) <u>Defense of the following lawsuit: City of Conroe et al. v. Lone Star</u>
 <u>Groundwater Conservation District (and the District's directors and general</u>
 <u>manager in their official capacities)</u> President Tramm stated that advice was received from counsel during the executive committee session.

B. Water Awareness and Conservation Committee - Billy Wood, Chair

- Brief the Board on the Committee's activities since the last regular Board meeting – Director Wood stated that the committee met on Thursday, October 8, 2015 and asked that Paul Nelson further update the Board on activities since the September board meeting.
- 2) Update on water efficiency, conservation efforts and public outreach Paul R. Nelson Mr. Nelson stated that several events took place since the last board meeting. September 24th, the Water Efficiency Network meeting was held; September 26th, LSGCD displayed the education trailer at the Woodlands Landscaping Event; and on October 8th, the Water Awareness and Conservation Committee met. Directors Moffatt and Wood, Ms. Jones, and Mr. Nelson were in attendance and discussed an outreach program for 5th grade students throughout Montgomery County, developed by Resource Action Programs. The program would include educational information for both students and teachers. Mr. Nelson noted that the committee was in

agreement to implement a program and tasked Mr. Nelson with gathering additional information. The San Jacinto River Authority expressed an interest in participating and are willing to help share the costs of a new educational program. Last, Mr. Nelson stated that Dr. Andres A. Salazar will be speaking at the Water Efficiency Network Meeting on October 22nd, an email reminder has been sent out. Mr. Nelson is hoping to see as many people as possible in attendance. Dr. Salazar will be discussing the development of Springwoods Village at the Woodlands Township.

3) Update on redevelopment of onsite detention project – Paul R. Nelson – Mr. Nelson stated that the committee reviewed and suggested revisions, which have been addressed. A meeting will be scheduled for later in October, at which point he will have the request of qualifications completed and sent out for bids.

C. Rules Development and Bylaws Committee - Richard J. Tramm

1) Brief the Board on the Committee's activities since the last regular Board meeting – President Tramm stated that there was a meeting on September 8th, to discuss a variety of items. A follow up meeting has been scheduled for October 22nd at 9 a.m. Director Weisinger asked for clarification that his email submission to clarify the September 8th committee meeting summary was received. Ms. Jones confirmed she had forwarded it on to the committee members.

D. Policy and Personnel Development Committee - Sam W. Baker, Chair

1) Brief the Board on the Committee's activities since the last regular Board meeting – Director Baker was not present. President Tramm stated that there was no meeting held since last month. Ms. Jones confirmed that was correct. Director McCoy inquired into the status the Committee's review of management following the July 13, 2015 special meeting. President Tramm stated that he could not speak on behalf of Director Baker but he would follow-up with him.

E. Findings and Review Committee - Richard J. Tramm, Chair

- 1) Brief the Board on the Committee's activities President Tramm stated that there was a meeting on October 6, 2015 to discuss the final draft of Task 1 of the Strategic Water Resources Planning Study.
- 2) <u>Summary Presentation of final draft technical memorandum for Task 1 of the Strategic Water Resources Planning Study John Seifert</u> Mr. Seifert gave a PowerPoint presentation on the" Summary of Technical Memorandum Regarding Groundwater Production and Water-Level Monitoring Program".

In summary:

- Groundwater production and well water-level monitoring program has been adequate.
- Additional effort is recommended in Montgomery County to correlate groundwater production by well with the source of the withdrawal, whether Chicot, Evangeline or Jasper aquifers.
- The static water-level (artesian heads) monitoring program is instrumental in assessing the effects of pumping on the aquifers, has provided valuable data in the evaluation both in and outside Montgomery County and should be expanded, including the addition of some shallow monitoring wells in anticipation of groundwater pumping occurring in additional areas.
- Largest increase in groundwater pumping since 2000 occurred in Montgomery County, while pumping in surrounding counties has generally decreased since 2000.
- In recent years, groundwater production in surrounding counties has had a limited effect on artesian heads in the Chicot and Evangeline aquifer screened wells in Montgomery County and a small effect on artesian heads in the Jasper Aquifer in Montgomery County. Copies of the presentation are attached hereto as Exhibit "C".
- 3) Discuss, consider, and possible action to accept "Technical Memorandum Regarding Groundwater Production and Water-Level Monitoring Program" for Task 1 of the SWRPS as recommended by the Findings and Review Committee It is the Committee's recommendation to accept this report. A motion was made by Director Bleyl, and seconded by Director Moffatt to accept the "Technical Memorandum Regarding Groundwater Production and Water-Level Monitoring Program" for Task 1 of the SWRPS. Motion was unanimous.
- 4) Groundwater Management Area 14 (GMA 14) Consider any possible suggested revisions the District may want to recommend to GMA 14 regarding the adopted proposed DFCs Director Bleyl began by thanking the staff for compiling the Draft Summary. He made reference to page 141 in the Summary Report. In summary, Director Bleyl stated, "the growth of the county needs to be considered." Following further discussion by the Board, Director Bleyl motioned to send a revised DFC to GMA 14 requesting that there be no more than a two percent reduction of storage in the Jasper aquifer over 50 years, and a one percent reduction in storage in the Evangeline and Chicot aquifers over 50 years. Director McCoy seconded the motion. Directors voting in favor: Bleyl, McCoy and Weisinger. Opposed: Directors Houston, Moffatt, Stinson, Tramm, and Wood. Motion failed.
- 5) Consider any possible guidance the board may want to give the District's representative to GMA 14 regarding development and adoption of DFCs Director Moffatt stated that while he was eager to see the results from the

strategic planning study, he did not believe that changing the DFCs now, without seeing those results, would benefit the District. A motion was made by Director Moffatt that the District approve forwarding the Summary Report as presented today to GMA 14, as required by law, and authorize the General Manager to notify the GMA that the District does not have any substantial changes to the proposed DFCs at this time. Director Houston seconded the motion. Director Weisinger asked that the record to show that he felt Director Moffatt's move would be a step in the wrong direction. "My comment is the District is currently permitted more than what we're doing and I think our board did not take that into consideration and stay with what you're recommending is not the spirit of what our groundwater district and our board should be presenting," Weisinger said. "Our current history that we have is exceeding that, and it does not look like there's a detriment to the aquifer, with somewhere in the neighborhood around 100,000 acre-feet. To me, I think that we're going backward." Director Bleyl stated that he agreed with Director Weisinger and agreed with Director Moffatt, in that he was eager to see the study results and would like to see the study be taken off hold. Further, he does not believe that we can reach our DFC based on what we are currently permitted for. Director Houston commented that when he last checked with District staff, the actual pumpage has been roughly 70,000 – 75,000 acre-feet for the last 5 years, except for 2011. He continued that most of the permits are over permitted based on what they are pumping, which is typical. He believes that based on those numbers that after conversion we could get pretty close to the 64,000 acre-feet DFC. President Tramm called for a show of hands in support of the motion. Directors voting in favor: Houston, Moffatt, Stinson. Tramm, and Wood. Voting against: Bleyl, McCoy, and Weisinger. Motion passed.

Director McCoy exited the meeting at 11:19 a.m.

F. Budget and Finance Development Committee - Jim Stinson, Chair

- 1) <u>Brief the Board on the Committee's Activities</u> Director Stinson reported that there was a meeting on October 9, 2015 to discuss audit proposals.
- 2) Review of Monthly Financial Reports Director Stinson reported that the financial statement indicated an actual income of \$2.36 million compared to year to date budget of \$2.95 million, and actual expenses are at \$1.40 million, compared to year to date of \$1.648 million.
- 3) Review 3rd Quarterly Investment Report 2015 Director Stinson noted that the third quarterly investment report is in the Board packets.
- 4) <u>Discuss, consider, and possible action regarding approval of Resolution amending authorized representatives for Texas Local Government Investment Pool (TexPool)</u>. A motion was made by Director Stinson to approve the

resolution to remove former bookkeeping staff and update to reflect the District's current bookkeeper, Kay Martin. Stinson noted that this authorization allows inquires only and does not authorize this person to initiate transfers. Director Houston seconded the motion. Motion was unanimously. Copies of the resolution are attached hereto as Exhibit D.

5) Discuss, consider, and take action to approve Budget and Finance Committee's recommendation of audit firm to serve as the District's auditor for the fiscal years of 2015 and 2016. – Director Stinson stated that 3 firms submitted proposals. The lowest bid was submitted by BrooksCardiel, PLLC, for \$8,000 for 2015-2016, the second bid was submitted by Herford, Lynch, Sellars & Kirkham was for \$9,800, and the third was submitted by BKD for \$14,000. Mr. Anthony Cardiel introduced and gave some detail on his background to the Board. A motion was made by Director Wood, and seconded by Director Bleyl to hire Mr. Cardiel for a two year term. The motion passed unanimously.

G. Professional Services Review Committee - Rick Moffatt, Chair

1) <u>Brief the Board on the Committee's activities</u> - Director Moffatt stated that there was nothing new to report at this time though he anticipated scheduling a meeting soon.

ENGINEERING REPORT:

Mark Lowry, District Consultant, reported that most of his activity during the month was routine, and a copy of his report is included in the Board's packet. He affirmed there is an error on #2 of the report. The correct date should be September, not August.

GENERAL MANAGER'S REPORT:

Ms. Jones stated that the majority of items included in her report had been discussed under earlier items on the agenda and she had nothing further to report or add at this time.

GENERAL COUNSEL'S REPORT:

Mr. Sledge commented working with co-counsel in Defense of the District's lawsuit with the City of Conroe et al. He added that the Lieutenant Governor issued his first round of interim charges to the Senate Committee, which included charges to the State Affairs, Senate Natural Resources and Economic Development and Senate Agriculture, Water and Rural Affairs Committees. The water charges were submitted primarily to Senator Perry's Ag, Water and Rural Affairs Committee. He continued that the significance of that was that there had been rumors that the water charges were going to go back to the Natural Resources Committee but that does not seem to be the case. For the first time in a few years, the water charges were

minimal and included a general charge reviewing the ownership production and transfer of surface water and groundwater and a charge to monitor the TWDB's identification and designation of brackish groundwater production zones (from last session) and a general charge on making recommendations on approving the process on developing and executing the state water plan. Mr. Sledge stated that the Senate Natural Resources Committee also had a charge to review agency permitting procedures to try to streamline them, which is an ongoing activity involving TCEQ.

Shauna Fitzsimmons followed with an update on injection disposal well activity in Montgomery County. She stated there were two injection well applications filed. The first on August 3rd by Denbury Onshore and the second on September 1st by Wheeler Operating Corporation. The District protested due to groundwater concerns and the potential for contamination. Since the filing, there were negotiations with the applicants to address those concerns, with Denbury Onshore withdrawing their application last month, followed by Wheeler Operating, who withdrew their application last week. There are currently no applications pending.

PUBLIC COMMENT:

There was no public comment.

NEW BUSINESS:

President Tramm addressed Director McCoy's earlier comment regarding the Policy and Personnel Committee. He clarified that there was a meeting scheduled for this past August, but Director Weisinger requested it be cancelled. He further explained that although he cannot speak for Director Baker, he is aware that there have been scheduling issues amongst committee members. President Tramm stated that he will make sure Director McCoy receives the additional information and will also follow up on the development and report back to the Board.

There being no further business, Director Weisinger made a motion to adjourn the meeting; Director Bleyl seconded the motion, therefore the meeting was adjourned at 11:29 a.m.

TASK 1 PRIMARY OBJECTIVES

- Collect and analyze groundwater production, and water-level data from public and private sources for the Chicot, Evangeline, Jasper and Catahoula aquifers in Montgomery County and evaluate the adequacy of the current monitoring and groundwater production reporting program. Provide recommendations for improvements to the program.
- Subordinate to effort in Montgomery County, collect and review groundwater production and well waterlevel data in surrounding counties and provide recommendations for its utilization as applicable to Montgomery County groundwater resources evaluation.

TASK 1 PRIMARY COMPONENTS (cont'd)


- Compile and analyze static water level (artesian head) and groundwater production data and surface water use in part of the NHCRWA area. Provide conclusions regarding aquifer response to the reduction in groundwater pumping.
- Review production and monitoring data for Montgomery County for about one year after January 1, 2016 scheduled conversion and provide results regarding aquifer response due to conversion.



















SUMMARY OF RESULTS

- Groundwater production and well water-level monitoring program has generally been adequate.
- Additional effort is recommended in Montgomery County to correlate groundwater production by well with the source of the withdrawal, whether Chicot, Evangeline or Jasper aquifers.
- The static water-level (artesian heads) monitoring program is instrumental in assessing the effects of pumping on the aquifers, has provided valuable data in the evaluation both in and outside Montgomery County and should be expanded, including the addition of some shallow monitoring wells in anticipation of groundwater pumping occurring in additional areas.

SUMMARY OF RESULTS (cont'd)

- Largest increase in groundwater pumping since 2000 occurred in Montgomery County.
- Pumping in surrounding counties has generally decreased since 2000.
- In recent years, groundwater production in surrounding counties has had a limited effect on artesian heads in the Chicot and Evangeline aquifer screened wells in Montgomery County and probably a small effect in artesian heads in the Jasper Aquifer in Montgomery County.



Potentially relinquish some monitor wells in areas with numerous, closely spaced wells and replace them with monitor wells in recommended areas









RESULTS OF REDUCTION IN GROUNDWATER PUMPING IN NORTH HARRIS COUNTY

- By 2014 reductions averaged 3.3, 22.5 and 3.6 mgd from the Chicot, Evangeline and Jasper aquifers, respectively, in the NHCRWA.
- Influence of reductions in pumping evident in three aquifers.
- The effects of the reductions in groundwater pumping were most evident in the immediate areas of the reductions.

RESULTS OF REDUCTION IN GROUNDWATER PUMPING

- Chicot Aquifer artesian heads stabilized to potential rise
- Evangeline Aquifer artesian heads recovered 20 to 60 feet
- Jasper Aquifer artesian heads decline reduced from 15 feet per year to 5 or less feet per year

RESULTS OF REDUCTION IN GROUNDWATER PUMPING (cont'd)

- Artesian heads in the Chicot, Evangeline and Jasper aquifers will recover or rise in Montgomery County in response to future reductions in groundwater pumping as a surface water supply is introduced in the county.
 - Magnitude of artesian head recoveries will be greatest in areas of reduced groundwater pumping
 - Magnitude of recoveries will vary directly with the amount of reduction in groundwater pumping

SUMMARY OF MAJOR COMMENTS

Comments did not disagree with the recommendations for future groundwater production and water-level monitoring improvements

Comments did not disagree with assessment of aquifers response to reductions in pumpage in North Harris County.

- C: Recommendation for general grid spacing for monitor wells.
 - A: Even distribution of monitoring wells is an objective in spacing of wells.

(cont'd)

- C: Request for a micro review of pumpage and waterlevel data.
 - A: This is a study to review the adequacy of the monitoring program, not a micro-scale study.
- C: Request monitoring network outside Montgomery County.
 - A: Wells, as available outside Montgomery County, are/will be used.
- C: Request for expansion of water-level monitoring in aquifer outcrops.
 - · A: Expansion recommended.
